ABOUT US



Glendower Golf Club is one of South Africa's most prestigious golf clubs and a cornerstone of championship golf in Gauteng. Established in 1937, the club has built a reputation for its outstanding course design, rich history, and role in hosting major international tournaments.

HISTORY AND HERITAGE

The club began in 1935 when ten Johannesburg businessmen purchased the farm "Rietfontein" which was to become "Glendower" with the vision of creating a country club and world-class golf course. The course was designed by renowned English golf architect Charles Hugh Alison and constructed by South African professional golfer Arthur Tomsett. The course officially opened on 7 March 1937, quickly earning a reputation as one of the finest parkland layouts in the country.

Just two years after opening, the club hosted the Transvaal Open Championship, which was won by legendary South African golfer Bobby Locke with a record score of 265. At the time, this was considered a World Record for a Major Tournament. This early success helped establish Glendower as a leading tournament venue in South Africa.

In 1973, the grounds were declared a nature reserve to preserve the abundant birdlife and natural environment on the property, adding ecological significance to the club's sporting legacy.

THE CHAMPIONSHIP COURSE

Glendower is an 18-hole, par-72 parkland course stretching over approximately 6,700–7,000 metres depending on the tees.

The course is known for:

- Tree-lined fairways that demand accuracy
- 64 strategically placed bunkers
- Water hazards on 11 of the 18 holes
- Fast, high-quality greens rebuilt to USGA standards during a major renovation in the 1980s.

The layout blends beauty with difficulty, providing a stern test even for elite professionals.

MAJOR TOURNAMENTS

Glendower has hosted numerous prestigious tournaments, including the South African Open on multiple occasions.

Notable winners at the venue include:

- Brandon Stone (2016)
- Graeme Storm (2017)
- Chris Paisley (2018)

These events have helped cement Glendower's status as one of the premier championship venues in the country.

REPUTATION TODAY

Today, Glendower Golf Club is consistently ranked among the top golf courses in South Africa, often appearing in national Top-10 lists. The club offers world-class facilities including a driving range, practice greens, PGA coaching, a professional pro shop, and a renowned clubhouse experience.

With its combination of tradition, championship pedigree, and beautiful parkland setting, Glendower remains a benchmark for golf excellence in South Africa.

CARTS AND CADDIES

GOLF CARTS

Glendower has **40 carts** charged at **R580** per cart. Should you require more, they can be hired in at a rate of **R750**.

- Carts are subject to availability and must be pre-booked.
- Only drivers with a valid driver's Licence may operate golf carts.
- A signed indemnity is required before carts may be used.
- Damage to carts will be billed to the organizer.
- Contributing factors, such as weather, may result in the Management disallowing their use if it is deemed that damage to the course may result.
- Disallowing the use of carts does not constitute grounds for cancellation if the course is still playable for walking golf.
- If there is a player who has a medical condition requiring the use of a cart, a valid medical certificate must be provided for consideration for the use of a cart under the circumstances of carts not allowed.

CADDIES

- Glendower has **55 caddies** available.
- Caddy Foundation Fee - **R70**
- Caddy with Halfway meal - **R420**
- Additional caddies must be pre-booked.
- Caddies **MAY NOT** be offered alcohol on the course. **Should this happen, the player who offered the alcohol will be asked to leave the premises.**

SPONSOR HOLES

WATERING HOLES AND BRANDING

- Glendower allows a maximum of four [4] alcoholic watering holes on the Course.
- A mobile golf cart is available to roam the course as a 5th watering hole with sponsored drinks at a rental of **R500**.
- All beverages, including ice, will be available at 10h00.
- Alcohol and soft drinks will be charged based on consumption and replenished as needed.
- If the client requests specific quantities, those will be charged for, and no refunds will be accepted.
- Client is responsible for checking and accepting stock issued by the F&B department.
- We do not accept any returns on stock ordered and purchased.
- Extra stock can be ordered during play.
- All drinks will be transported to the watering hole by the course staff. No additional stock will be provided after 15h00.
- **NB!! No private vehicles are permitted on the course unless pre-arranged with the club. Marchals will escort the vehicles to the relevant holes.**
- **Brand activation and watering holes must be agreed with the Club, which will provide the necessary assistance for setup and teardown.**

SPONSORSHIP COSTS

- Prime Locations (1st/10th/18th Tee): **R5,000+**
- Par 3 Holes (Often includes Closest to the Pin): **R2,500**
- Standard Holes: **R1,000**

Associated Costs & Options

- Watering Hole/Manned Station: A "corkage" or service fee of **R2,500** applies if you are providing your own drinks and food.
- Branding Assistance: **R850** for club staff to set up your branding.

Golf cart GPS screen advertising rates :

- Daily/ Once off – **R250.00** static per hole.
- Daily/ Once off – **R500.00** video per hole.

What is Included?

- Space for banners (A-frame/teardrop/gazebo), a table, and two chairs. at a cost of **R250**
- Opportunities to interact with players.

FOOD AND BEVERAGE

FOOD & BEVERAGE

- All catering must be arranged through the Club.
- Special dietary requirements must be finalized at least **7 days** before the event.
- Beverage stations and on-course activations must be approved in advance.
- The Club holds a Liquor Licence (GU500210C) with the Gauteng Liquor Board.

In terms of this Licence:

- Alcohol may only be served from 10h00. **Glendower reserves the right to suspend or terminate the event where the Liquor License Legislation is breached.**
- Glendower encourages Alcoholic beverages to be bought from the Club. If drinks/dry snacks from outside are supplied at a sponsored hole, a corkage fee of **R2,500** per hole will be added (subject to change).
- If the organizer chooses to cancel the event voluntarily, all prepared food will be billed for.
- For prize giving, the food & beverage operation provides extra food for the buffet station; therefore, no takeaways are permitted.
- One waiter [1] per ten [10] guests will be provided for all prize-giving dinners, and after golf functions.

NB: For all groups with 12 or more golfers, a mandatory 10% gratuity will be added to all Food & Beverage charges and included in the final invoice.

SCORING AND RULES

SCORING.

- The event format must be confirmed at least **7 days** in advance.
- Recommended formats for corporate golf days include Alliance, Betterball Stableford, and a mystery scorecard.
- Starting sheets, cart labels, and scoring templates will be prepared based on final player lists.
- Live Scoring (ScoreCapture) is available at a cost of **R150** per player
- Starters and Marshals will be provided at no additional charge.
- Nearest to the Pin markers will be provided and collected after the round.
- Nearest to the Pin holes are 3 | 6 | 14 | 17
- Longest drive holes are 2 | 8 | 13 | 15
- Hole in One hole is 17

FUNCTIONS AND VENUE

- All Corporate Golf Days and events need to end and be off our premises by the latest 22h00. (After 10pm it is very difficult for our staff to get transport home)

DRESS CODE

ON COURSE

- Collared golf shirts and golf t-shirts
- Tailored slacks or knee-length shorts
- Golf shoes with soft spikes

CLUBHOUSE

- Smart casual or golf attire
- No vest shirts or sandals

STANDARD RULES

Standard Rules

- The usual courtesies are expected from players, such as repairing pitch marks, filling of divots, and the raking of bunkers.

Lightning Protocol

- Glendower has an automated siren system for lightning.
- **One long siren** - Course closed, play suspended
- **Two short sirens** - Course is open, resume play.
- Players must adhere to this rule. Anyone who ignores the siren and continues play does so at their own risk and will lose their place in the field upon resumption, to those golfers who have complied with the siren.

COURSE AND CONDUCT

COURSE RULES & CONDUCT

- All players must follow Glendower's course rules.
- All players must abide by Glendower's dress code and etiquette.
- All players must familiarize themselves with SAGA (South African Golf Association) requirements and abide by them.
- The organizer is responsible for their guests' conduct.
- Damage to course property or equipment will be charged to the organizer and will result in the removal of those involved.
- Instructions from Marshalls must be obeyed at all times.
- The use of profanity and threats against staff will not be tolerated and will result in immediate removal from the premises.

PRIZES & SPONSORSHIP

- The organizer supplies prizes unless otherwise agreed.
- Sponsorship signage must be approved before installation.
- **NO** branding may be placed on greens or sensitive course areas without the express permission of the Club.

DANGEROUS WEAPONS

- No dangerous objects or weapons may be brought onto the premises. This includes firearms, crossbows, and knives.



MEDIA AND ACCESS



PHOTOGRAPHY & MEDIA

- The course may capture photographs for internal use.
- The organizer is responsible for obtaining participant consent for photography.
- Drone Footage and an edited Video of your day is available at a cost of **R3500**.

SECURITY GATE ACCESS

- Please submit your alphabetical guest list **2 days** before your golf day.
- This should include all participants, event assistants, delivery personnel, and any guests attending the dinner.
- Upon arrival, guests must present a driver's license and a valid vehicle license disk.
- **All guests must present acceptable identification**

TERMS AND CONDITIONS

BOOKINGS & CONFIRMATION

- All golf day quotes are valid for **7 days**.
- A deposit of **50%** of known costs or a minimum of **R30 000** is required to secure the day.
- Final confirmation of player numbers, catering requirements, and special requests must be provided **NO LATER** than 14 days before the event date.
- The organizer will be billed based on the **FINAL CONFIRMED** numbers, regardless of how many golfers actually attend.
- All known costs must be paid no later than 14 days **BEFORE** the golf day.
- Additional charges incurred on the day (cart hire, bar tabs, extra meals, prizes, etc.) must be paid immediately after the event.

AMENDMENTS

- These Terms & Conditions may be updated from time to time.
- The organizer will be informed of changes as soon as possible.

CANCELLATIONS & REFUNDS

GLENDOWER RESERVES THE RIGHT TO CHARGE A CANCELLATION FEE, WHICH WILL BE CALCULATED AS A PERCENTAGE OF YOUR GOLF DAY AS FOLLOWS:

- **Cancellations must be submitted in writing.**
- **Cancellation at least 30 days before the golf day:** No cancellation fee.
- **Cancellation between 15 days - 29 days before the golf day:** 25% of the total cost
- **Cancellation within 14 days prior:** 50% of the total cost.
- **Cancellation within 2 days prior:** 100% of the total cost.
- In the event of this booking being cancelled by Glendower Golf Club due to the weather or other circumstances, the Club will supply an alternative date or full refund of Green Fees, Carts, Waterways, Caddies etc... Food that has been prepared will not be refunded.
- Should the weather force Glendower Golf Club to close the course during play, then there is no refund

LIABILITY

- Glendower Golf Club is not liable for injury, loss, theft, or damage to private property.
- Participants engage in golf activities at their own risk.
- The organizer is responsible for event insurance if required.
- By your signature, the organizer warrants they are authorised and accepts full responsibility for the actions of its guests and agrees to be liable for any damages suffered by Glendower resulting from any act or omission of its guests.
